

1. Tender documents will be open for sale on payment Rs. 1,000/- in cash (non refundable). These can be obtained on all official working days on before 22.07.2024 between 11.00 A.M. to 05.00 P.M, from the "**Office of the Resident Commissioner, Government of Chhattisgarh, 7-8th Floor, Plate-C, Block-2, NBCC Office Complex, Kidwai Nagar (East), New Delhi-110023.**" The same can be downloaded from the website www.rcchhattisgarh.gov.in.
2. In case tender documents is downloaded from the website, the cost of Tender Document of Rs. 1,000/- should be enclosed with the Tender in the form of Demand Draft of scheduled Bank in favor of the "**Ressident Commissioner, Chhattisgarh Bhawan, New Delhi.** "
3. The tender will be submitted in the "**office of the Resident Commissioner, Government of Chhattisgarh, 7-8th Floor, Plate-C, Block-2. NBCC Office Complex, Kidwai Nagar (East), New Delhi-110023**" on or before 23.07.2024 upto 03.00 P.M.
4. The tenders will be opened on 23..07.2024 at 03.30 P.M. in presence of the bidders who desired to be present or otherwise shall be opened in the presence of Officers designated by Resident Commissioner, Chhattisgarh Bhawan, New Delhi.
5. The EMD of Rs. 5000/- in the form of Demand Draft of scheduled Bank issued in favor of "**Resident Commissioner, Chhattisgarh Bhawan, New Delhi**" is enclosed with the tender form, failing which the tender will be summarily rejected.
6. The EMD of the unsuccessful bidders will be refunded within 07 days of award of order to the successful bidder.
7. The tender should be submitted in **sealed cover** super-scribed as "**SALE OF SCRAPS**".


8. The Tenderers are free to inspect the Scrap at "**Chhattisgarh Sadan, 8-12, Factory Road, Safdarjung, New Delhi.**"
9. The tender shall be awarded based on the highest offer received from firms/individuals.
10. The successful Tenderer shall deposit the total bid amount in the form of Demand Draft of scheduled Bank issued in favor of "**Resident Commissioner, Chhattisgarh Bhawan, New Delhi**" towards the cost of scrap within three working days from the date of awarding the order.
11. In case of non-lifting in schedule time, the penalty will be of Rs. 1000/- per day for addition 4 (Four) Days. Further delay will lead forfeiture of EMD. The Resident Commissioner will dispose the materials as per his discretion.
12. This office shall not be responsible financially or otherwise for any injury to the bidder or person deployed by the bidder in the course of performing the Disposal Activity.
13. The truck/tempo for Scrap lifting and carrying shall be arranged by tenderer at their own cost. The tenderer shall have to make arrangement for loading of scrap to truck/tempo at their own cost and office of the Resident Commissioner, Chhattisgarh Bhawan, New Delhi will not pay any charges for the same.
14. The Resident Commissioner, Chhattisgarh Bhawan, New Delhi reserved the rights to accept/reject any or all the tender/tenders without assigning any reason.
15. In the event of non-compliance of any terms and conditions mentioned herein, this office reserves the right to cancel the sale order and forfeit the EMD.
16. Conditional bids will be rejected out rightly.
17. The bidder, who quoted the rate lower than the reserve price, will not be entertained.
18. All disputes are subject to Delhi jurisdiction.
